ILLNESS PROTOCOL DURING COVID-19 PANDEMIC

School expectations of student and family if COVID symptoms are present in student or member of household

- 1) If a student, or a member of their household, begins showing any of the symptoms related to COVID-19, out of an abundance of caution we require that student not to come to school and for the parent to contact our COVID Liaison to discuss.
- 2) Depending on the severity and concern related to the symptoms, it may be required for the ill student or household member to be tested for COVID-19. In that case, it will be required for the test result to come back negative before the student is able to return to campus.
- 3) If a student or a member of their household tests positive for COVID-19, the COVID Liaison must be informed right away. NPA will follow the protocols outlined in section 2 of our reopening plan which involves the school consulting with public health officials to determine our course of action which may lead to full or partial closure of the campus.

Daily screening

- 1) All students and families are required to conduct a daily health screening at home. Take student's temperature and check in about how they are feeling. Consider health of all members of the household. If student or any member of household has had any of the following over the previous 24 hours then student must stay home: sore throat, cough, chills, body aches for unknown reasons, shortness of breath for unknown reasons, loss of smell, loss of taste, fever at or greater than 100 degrees Fahrenheit.
- 2) Students will also be screened upon their arrival at school and will be sent home if they show or report any of the symptoms listed above.

If a student becomes ill while at school

- 1) If a student feels ill while at school they will be required to wait in the Nursery until a parent or guardian can arrive to pick them up. If a student drove themselves to school, they may simply check in with a teacher and leave school if they are feeling ill. This student should stay home for at least 24 hours and follow up must occur with the COVID Liaison before the student can return to school.

DAILY HOME & SCHOOL SCREENING QUESTIONS

- 1) Have you or anyone in your household had any of the following symptoms in the last 24 hours: sore throat, cough, chills, body aches for unknown reasons, shortness of breath for unknown reasons, loss of smell, loss of taste, fever at or greater than 100 degrees Fahrenheit?
- 2) Have you or anyone in your household been tested for COVID-19 in the past 24 hours due to having COVID related symptoms?
- 3) Have you or anyone in your household cared for an individual who is in quarantine or is a presumptive positive or has tested positive for COVID-19 in the past 24 hours?
- 4) Do you have any reason to believe you or anyone in your household has been exposed to or acquired COVID-19 in the past 24 hours?
- 5) To the best of your knowledge have you been in close proximity to any individual who tested positive for COVID-19 in the past 24 hours?

If answer is "yes" to any of the above then student must stay home from school and parent must contact COVID Liaison to discuss next step.
